(1) Costs for participation in the ENCJ are reimbursed on a biannual basis, in line with ENCJ guidance. Costs can be reimbursed to the following levels:

(2) Reimbursement pending but not yet received

**Accommodation:** The maximum amount to be reimbursed is € 150 (average) per night (a maximum of 1 night per trip), per member.

**Travel arrangements:** The Members of the Board will make their own Travel arrangements. Reimbursement will be on the basis of economy class by the most economical route and whenever possible reduced rates will be used. Train journeys will be reimbursed on the basis of 1st class. The reimbursement for travel costs is fixed at € 400 maximum.
