There is an ongoing appeal before the SAC at the instance of the defender in this case as the appellant. Sheriff Cruickshank forwarded a supplementary note to the SAC, which may impact on the credibility of an affidavit before the SAC by the appellant. Given the above, Sheriff Cruickshank considered it was inappropriate for him to consider interim orders or be further involved in this case given that this case, and the case on appeal have close connections.

The Sheriff refused the motion on the basis that Mr Gough was not representing the Respondent and there was no conflict of interest.
07/01/2022	Court of Session (Inner House)	Lord Woolman	William Frederick Ian Beggs v The Scottish Legal Aid Board and The Scottish Information Commissioner (P1259/18)	Agents for the Petitioner	Lord Woolman dealt with, as an Outer House Judge, a previous iteration of this case where the petitioner challenged SLAB's refusal of legal aid [2018] CSOH 13; The Petition was refused by Lord Woolman in that case. Lord Woolman is of the view that a bystander might reasonably consider his Lordship has already made up his mind, or at least may be prejudiced in one direction, having already decided a different version of the same issue after a substantive hearing.
