

Travel and subsistence expenses for the period of 01 July – 30 September 2022 (Judges of the Court of Session and High Court of Justiciary)

Senators are required to go on circuit from time to time, meaning that they sit in various courts throughout Scotland. Depending on the distance from Edinburgh (location of Senators' base court) they may reside in accommodation near the court or travel daily.
